



- Blueprint for digital transformation in legal metrology


## Practical Experience and Workshops:

## Initial e-Learning course for 2025

---

- The self-learning online course should be accessible, and the knowledge should be usable for organizations from all world regions
- The initial course will be an entry point into the field of digital transformation for experts in legal metrology include with
- Foundations for future e-Learning modules/ courses that can be more specific or technical
- We already have specific and technical knowledge in the SC e-Learning that we should utilize for future technical e-Learning courses to enable metrologists to e.g., digitalize measurements (one of the expert fields within IMEKO TC6)



## DTG SC e-Learning – Roadmap (2/2)

### External support

- Expert will conduct and document at least 10 interviews with people from OIML pillars and stakeholders regarding their needs and expectations for the e-Learning course
- Expert will conduct and document their research of material on fundamental principles and training courses on digitalization with topics relatable to legal metrology
- Expert will provide sorted and filtered documented outcomes and material (storyboard) to form an e-Learning course on digitalization in legal metrology and conceptualizing the syllabus of e-Learning courses on digital transformation in legal metrology
