2CD OIML R 137-1 & -2 Gas meters

Dear colleague,

After OIML R 137-1 Gas meters was approved by CIML in 2006 and effectively published in 2007, and the responsibility for this Recommendation was transferred to TC8/SC7, the secretary started the work on drafting Part 2 Metrological controls and performance tests.

During this work, it was identified that a few minor changes in Part 1 would be necessary, although there is no formal project for the revision of Part 1.

In accordance with the philosophy propagated by BIML, new Recommendations are to be split in 3 distinctive Parts: with the requirements, the metrological control and tests, and the Report Format respectively.

Taking this into account and expecting that the current project for part 2 will also lead to a revised Part 1, the secretary investigated what further changes would be advisable. This lead to a first committee draft R 137-1 and -2 which was published for comments in October 2009. The compiled comments have been responded upon and together with a preliminary 2CD were discussed during a TC 8/SC 7 meeting on 1 and 2 July in Delft. The results are included in the final 2CD (TC 8/SC 7/023/2CD R137-1&2) which is now published on the TC/SC website.

For more information, please refer also to the temporary **Explanatory Note** in Part 1.

As preferred by BIML, the Parts 1 and 2 are combined in one publication. For that reason you will note that they are combined in one file and the numbering of the clauses is continued in Part 2.

For your convenience the 2 documents presenting the differences between the 2 CD and the 1 CD respectively between the 2CD and the pr 2CD have also been published. (TC 8/SC 7/023a/2CD R137-1&2 and TC 8/SC 7/023b/2CD R137-1&2).
